Abriendo Puertas/Opening Doors is the nation's first evidence-based, comprehensive training program developed by and for Latino parents with children ages 0 to 5. The 10 session curriculum, available in English and Spanish, promotes school readiness and parent advocacy by addressing best practices in the following areas: language development, early literacy, bilingualism, health, socio-emotional wellness, parent leadership and planning for family success. Abriendo Puertas/Opening Doors aims to improve the outcomes of the nation's Latino children by building the capacity and confidence of parents to be strong and powerful advocates in the lives of their children.

The Abriendo Puertas/Opening Doors Loteria, available in English and Spanish, is a game that combines the values, concepts, and fundamental objectives of the Abriendo Puertas/Opening Doors program. Each set includes 20 boards and 53 cards. The game can be played with any group of parents. When playing this Loteria, participants experience learning through cheerful and pleasant interactions.

The Abriendo Puertas/Opening Doors Loteria was developed with the input from hundreds of parents who rated it as highly effective in meeting these objectives:

- To support parents as their child's first teacher so they can effectively guide their development from 0-5 years of age.
- To provide parents with information they can use daily to take positive action in support of their child's school readiness
- To inform parents of topics vital to their child's healthy development.

The cost is \$10.00 per Abriendo Puertas/Opening Doors Loteria

plus sales tax, shipping and handling (\$2 for 1 set, \$1 for each additional set)

In some states, nonprofits are exempt from collecting and remitting sales/use tax on items or services they sell. 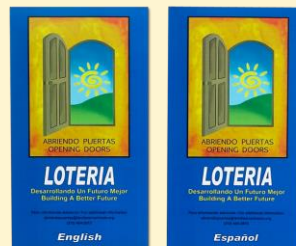
